Department of School Education, Government of Uttarakhand (DoSE) proposes to set up Learning and Training Centre's for providing professional coaching for Engineering and Medical entrance exams to school students at 13 districts across Uttarakhand. The private partner shall provide coaching for both Engineering and Medical entrance exams.

The space and infrastructure required for setting up Learning and Training Centre at district level would be provided by DoSE in existing Rajeev Gandhi Navodaya Vidyalayas or state Intermediate Colleges in Uttarakhand.

**DETAILED EXPRESSION OF INTEREST (EOI) FOR PROVIDING ENGINEERING  
AND MEDICAL ENTRANCE EXAM COACHING TO SCHOOL STUDENTS  
THROUGH PUBLIC PRIVATE PARTNERSHIP (PPP) MODE**

**1. Introduction :**

The main aim of Department of School Education is to formulate and implement various schemes for providing education to children in the state of Uttarakhand. For the rural poor and talented students the Government has introduced free and quality education through Rajeev Gandhi Navodaya Vidyalaya, residential school.

Secondary Education in India have been designed to prepare young students for higher education, though in reality only a small section of students enter higher education institutions. With a view to provide coaching facilities for Engineering and Medical entrance exams to the students, Department of School Education (DoSE) proposes to set up 13 Learning and Training Centre.

The Learning and Training Centre would be set up at district level in existing Rajeev Gandhi Navodaya Vidyalayas or state Intermediate Colleges in Uttarakhand.

**2. Project Details :**

- I. The space required for setting up Learning and Training Centre at district level would be provided by DoSE in existing Rajeev Gandhi Navodaya Vidyalayas or state Intermediate Colleges in Uttarakhand.
- II. The private partner would be allowed to use infrastructure available at existing schools for conducting coaching classes.
- III. The selected coaching institute will provide professional coaching for Engineering and Medical entrance exams along with study material to the students.
- IV. The private partner will conduct atleast following 2 coaching programmes throughout the Concession Period :

- a. 2 year course in engineering and medical entrance exams for class XI students
- b. 1 year course in engineering and medical entrance exams for class XII students

In additional to the aforesaid programmes the private partner can conduct crash courses, test series etc. after school hours.

- V. The selected coaching institute will provide free coaching including study material to 30 students of class XI for 2 year course and 30 students from class XII for 1 year course from Government Schools. The 30 students from Government School will be selected through entrance exams to be conducted by the Government. The process of selection of students for free seats will be the responsibility of the Government. The first 30 students scoring highest marks will be selected. Out of total 30 seats atleast 15 seats each will be reserved for girl child.
- VI. The private partner shall provide coaching for both Engineering as well as in Medical entrance exams.
- VII. The private partner shall integrate the coaching pattern with the prescribed syllabus of CBSE board examination. The selected coaching institute will be free to conduct its own qualifying written examination for need assessment study, gap analysis and selection of students (except for the students selected by the Government).

### **3. Broad Scope of Work :**

The scope of work for the Private Partner will include:

- I. To conduct coaching classes for engineering and medical entrance exams after school hours.
- II. To employ trained teaching and supporting staff. The continuity of the classes should not be affected by unavailability of teachers at any point of time.
- III. To develop and provide course curriculum.
- IV. To conduct qualifying examination, screening of students and pre examination counselling.
- V. To maintain records of number of courses being taught, duration of course, students records, number of students enrolling in each batch, performance level of individual batches etc.
- VI. Compliance with all regulatory/legal requirements.

VII. Avoid unauthorized usage of project infrastructure.

#### 4. Government Concession

- I. The space and infrastructure required for setting up Learning and Training Centre at district level would be provided by DoSE in existing Rajeev Gandhi Navodaya Vidyalayas or state Intermediate Colleges in Uttarakhand.
- II. The concession period would be for a period of six (6) years extendable based on achievement of service levels.

#### 5. Eligible Applicant :

5.1 The Applicants meeting the following technical and financial experience shall be eligible to apply for the Project :

##### A. Technical Experience :

The Applicant should meet the following technical criteria :

- i. The Applicant should be an institute registered as Firm/Society/Trust/Company, registered & incorporated in India and in existence in India for the last 4 years or more.

The Applicant shall submit relevant certificate of incorporation alongwith the Application.

- ii. The institute should have been providing continuous coaching for engineering and medical entrance exams for not less than 4 years for period ending 31.03.2010.
- iii. The institute should have permanent faculty of high professional competence for teaching of various subjects.

Detailed Bio data of atleast 10 permanent faculty member should be submitted.

- iv. The institute should have a track record of successful selection of students in engineering and medical entrance institute of repute. The success rate of the institute for past 2 years i.e. (2008-09 & 2009-10) should be atleast 75%. Success rate would mean percentage of students receiving admission call letters from Professional Educational institutions.

The institute shall provide self attested certificate of number of students selected in engineering and medical institutions of repute.

After the selection of private partner, DoSE may carry out independent audit for verification of records submitted by the private partner.

- v. The institute should have been providing coaching to at least 200 students per year for engineering and Medical entrance examination during for the last 2 years (2008-09 & 2009-10).

The institute shall provide self attested certificate of number of students to whom coaching is provided.

After the selection of private partner, DoSE may carry out independent audit for verification of records submitted by the private partner.

#### **B. Financial Experience :**

- i. **Networth Criteria :** Minimum networth of individual Applicant or Consortium should be Rs. 50.00 lakhs as on 31<sup>st</sup> March 2010 as per annual audited financial statements and
- ii. **Turnover :** The Applicant should have minimum annual average turnover of Rs. 100.00 lakhs during the last 3 completed financial years.

The Application must be accompanied by the audited annual financial statements of the Applicant (of all the members, in case of a Consortium) for the last 3 financial years.

5.2 The percentage equity shareholding of each member should be clearly indicated as per the format provided in Annexure 1 where the Application is made by consortium.

5.3 In case of consortium the maximum number of members allowed shall be three. Each of the members, whose technical and financial capabilities will be evaluated for the purposes of the EOI, shall subscribe to 26% (twenty six per cent) or more of the paid up equity of the consortium and shall further commit that each such member shall, for a period of 2 (two) years from the date of commercial operation of the Project continue to hold equity share capital not less than 26% (twenty six per cent) of the paid up equity share capital of the consortium.

5.4 The Applicant shall provide evidence of relevant experience with student details.

6. Last date for submission :

Applications should be submitted before 1400 hours IST on 05 March,2011 i.e. Application Due Date

DoSE may, in exceptional circumstances, and at its sole discretion, extend the Application Due Date by issuing an Addendum uniformly for all Applicants.

7. Late Applications:

Any Application received after the Application Due Date and time shall not be accepted by DoSE. Any such Application received after the Application Due Date shall be summarily rejected and returned unopened.

8. Submission of Application:

8.1 All applications shall be submitted in sealed envelopes. Applications submitted either by facsimile transmission or e-mail shall not be acceptable.

The envelopes shall clearly bear the following identification:

An Applicant cannot submit an Application in response to this EOI both as an individual and as a member of Consortium. In case an Applicant submits more than one Application in response to this EOI then all the Applications submitted by the Applicant would be rejected.
